This week, the market has relatively few major economic data releases. The key ones to watch are Wednesday's weekly initial jobless claims and Friday's University of Michigan Consumer Sentiment Index. However, the primary focus remains on the Federal Reserve's January monetary policy meeting minutes. While the market generally expects no significant surprises, recent economic data still indicate persistently high inflation, making it highly likely that the Fed will keep interest rates unchanged until at least June. This suggests that in the short term, market liquidity expectations will remain stable, and the stock market will likely continue its high-level consolidation.


From a technical perspective, the S&P 500 index is currently approaching the upper resistance zone of its consolidation range. Even if a short-term breakout occurs, it is unlikely to open up significant upside potential. Looking at the overall market sentiment, despite the index holding at high levels, the profitmaking effect remains weak, and market sentiment is beginning to show signs of exhaustion.

The biggest risk? The most concerning issue in the current market is that retail investors are excessively betting on a handful of star companies, particularly the Magnificent Seven in U.S. equities. While large-cap tech stocks remain



market favorites, the reality is that their prices are already high, valuations are stretched, and fresh growth catalysts are lacking. Combined with the broader indices being stuck in a consolidation phase, these star stocks, just like the market itself have entered a period of stagnation.

In other words, we are entering a phase where the market appears strong but offers limited opportunities. At this point, smart investors should avoid blindly following the crowd. 


